I. Each carries 4 Marks.

- (1) Calculate the Duty Pay, Leave Salary and other Compensatory Allowances of an officer who had availed HPL for 8 days in February 2013 and March 2013. Pay = 18300, DA @ 53%, HRA = 550 and HTA = 280.
- (2) A Senior Grade Assistant in the Secretariat drawing pay Rs. 20240. In the Scale of Rs. 16180-400-16980-440-18740-500-21240-560-24040-620-27140-680-29180 as on 01.07.2010 was directly promoted to the post of Section Officer on 18740-33680 from 11.10.2010, without officiating in the intermediary post of Assistant Section officer in the Scale of 16980-31360. On 20.10.2011 he was reverted as Assistant Section Officer and appointed as Section Officer on 01.11.2011. Regulate his pay up to 01.10.2013.
- (3) Calculate the Earned Leave account of an officer in a vacation department from the given details of service. Entry in service=1.6.1985, Vacation – April & May (61 Days), Enjoyed full vacation during 1.6.1986–31.5.87. Prevented from enjoying vacation in 1.6.1987–31.5.88. Not enjoyed 20 days of vacation in 1.6.1988–31.5.89. Not enjoyed 25 days of vacation in 1.6.1989–31.5.90. Leave from 1.9.89 to 31.10.1989.
- (4) An officer with HQ at Kottayam was deputed for training at TVM for the period from 1.2.2013 to 30.4.2013, during which he had availed E/L for 20 days from 22.2.2013, HPL for 8 days from 10.4.2013. What is the admissible rate of DA for halt, if the rate of DA is Rs. 200?
- (5) Fix up the qualifying service of an officer from the particulars of his service given below. Date of birth=28.5.1967. Entry in service=7.7.1987. Voluntary retirement =14.7.2015.

- (1) An officer drawing a pay of Rs. 29860 in the scale of Rs. 24040-38840, DA @45% HRA @ 250 was promoted to a post in the scale of 32110-44640 and posted in an office in the Corporation area. He handed over charge in the AN of 10.07.2012 and took charge at the new station on the FN of 19.07.2012. His pay was fixed at Rs. 31360 w.e.f. 10.07.2012. Regulate his pay and allowances for the month of 07/2012.
- (2) Find the Average Emoluments of the officer who is due to retire from service on superannuation on 31.03.2015. Pay as on 01.07.2014=27140. He was under suspension from 01.06.2014 to 27.6.2014, which was treated as LWA and he was on suspension from 10.08.2014 to 21.09.2014, which was not regularized and he was on Commuted Leave from 01.03.2015 to 31.03.2015.

- (1) An officer drawing pay @ Rs. 18740 from 1.7.2012 in the scale of (15380-400-16980-440-18740-500-25900) was promoted to officiate in the higher post on 13.9.2012 in the scale of (Rs. 16980-440-18740-500-21240-560-24040-29180). He was reverted to the lower post on 23.3.2013 and again promoted on 2.12.2013. Regulate his pay upto 1.7.2015.
- (2) What is the PTA admissible to an officer, who was on duty on all days in 06/2014? But he has performed tour on 15 days only. The monthly rate of PTA is Rs. 400 and the prescribed minimum days of tour is 20 days.
- (3) The head of a Dept: performed the following journeys. Calculate the TA admissible.
 - 1) 4.3.2012 (6.10 am-10.40 am) TVM-EKM By rail in (2nd AC) 220 Kms. Fare Rs. 535.

 - 3) 6.3.2012 (2.30 pm-8.30 pm) TVM-New Delhi By air fare Rs. 11850
 - 4) 7.3.2012 and 8.3.2012 Attended conference.
 - 5) 9.3.2012 and 10.03.2012 Availed holidays.
 - 6) 11.3.2012 (8.20 am-11.30 am) return to HQ by air.

LWA for 5 years w.e.f. 17.11.1988 under Appendix-X11A, Pay Rs. 24040 on 01.07.2014 in the scale of pay of Rs.21240-560-24040-520-27140-680-750-32860-820-36140-900-37040. DA=86% w.e.f. 01.01.2015. Calculate Pension, DCRG, Commutation of Pension and Family Pension. (10)

VI. A Grade I Officer with HQ at Kalpetta was transferred to TVM on public interest and he shifted to the new station on 11.09.2013 (AN) Tuesday, by rail 1st Class. Personal effects weighing 2000 Kg were transported to new station on 20.09.2013 by lorry. His son aged 19 years preceded him on 01.09.2013 and his wife and child aged 2 years succeeded him on 11.12.2013. (Pay = 40640, DA = 250, IC = 0.50/Km, Distance from Kalpetta to Calicut = 70 Kms, Rail distance from Calicut-TVM = 400kms. 1st class rail fare = 952, Goods Freight charges for 400 Kms = 417.10/tonne. Loading and Unloading charges = 600/each. 15th, 22nd, Sundays and 14th, 16th, 17th, 18th and 21st of September are holidays. Calculate his transfer TA and say the date on which he has to take charge at the new station. (10)
