The Register numbers of the candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

The candidates who have secured 66 (Sixty Six) marks and above are included in the Main List of this Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

SC/ST candidates included in the Short List are required to produce 2 (Two) copies of Community Certificate issued for producing before the Public Service Commission.

The Candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/STDD Dated 26.09.2009 shall produce the same along with the other documents mentioned above as and when called for. Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates and such candidates who are included in the supplementary lists will not be considered for this selection if they fail to produce NCLC/CC as the case may be.

The date, time and place of interview will be intimated in due course. According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts after publication of the Ranked List for the post. Detailed instructions will be found in the Ranked list notification for the post.

Copy of the answer scripts of the OMR test held on 12.10.2011 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List. Candidates whose register numbers are not included in the Short List are advised to refer to the Invalidation Notification No. ER V(1)/5248/2011/EW dated 10.05.2013.
