Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (3) **10 (Ten)** eligible and qualified candidates who have secured topmost marks in the OMR examination are included in the Main List of this Short List. The marks secured by the last candidate is **78.67 (seventy eight (point) six seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Casts, Scheduled Tribes, Other Backward Classes and Economically Weaker Section; necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) The short List has been prepared based on the details furnished by the candidate in the application and subsequent claim will not be entertained at any stage. If any of the documents produced by any candidates is found defective the commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Short List are required to produce Community Certificate/Non Creamy Layer Certificate/EWS Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **01-08-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (9) No answer scripts of Candidates attended the OMR Test held on 01.08.2023 have been invalidated. (Refer Notification No : ERI(2)4401/2023/EW Dated. 13/12/2023 (published along with this notification))
