The marks secured by the last candidate in the Main List is **58 Marks( fifty eight Marks)** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Cates, Scheduled Tribes, Other Backward Classes (and other reserved categories if any ) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

**Note :- (4)** Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date,time and Venue of both will be intimated in due course.

**Note :- (5)** The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

**Note :- (6)** According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

**Note :- (7)** SC/ST Candidates included in the Short List are required to produce Community Certificate (In Form III / Digitally signed) issued by the Tahsildar and candidates belonging to other reservation group should produce Non Creamy Layer Certificate and EWS candidates should produce EWS certificate issued by Village Officer at the time of OTV.

**Note :- (8)** Copy of answer scripts of the **OMR Test** held on **12-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer Script of one candidates is invalidated as per Notification No **ER II (2) 4009/2023/EW** dated **01.11.2023**
