NOTE (1) :- According to the existing procedure, revaluation and rechecking of Answer Script is not allowed.

NOTE (2):- Candidates who wish to obtain the image and tabulation sheet of their answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of answer sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie on or before 18.01.2024). Application submitted in any other manner (ie via email/Tappal/Direct) will not be considered. A copy of an answer sheet will be issued only once to a candidate. Copies of answer sheets invalidated due to any defect will not be issued.

NOTE (3) :- Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to **THE SECRETARY, KERALA PUBLIC SERVICE COMMISSION, HEAD OFFICE, PATTOM, THIRUVANANTHAPURAM-4**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with a Notarized Affidavit and a self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.
