Note :- (4) Candidates included in the Short List are required to produce Community Certificate issued by the Revenue authority and shall produce the same along with the other documents at the time of OTR Verification.

Note :- (5) According to the existing procedure revaluation of answerscripts is not allowed but answerscripts can be rechecked after the publication of Rank List. Detailed instructions will be published in the Rank List to be published for the post.

Note :- (6) Copy of answer scripts of the OMR Test held on **20-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer Notification No : ER I (2) 3780/2023/EW dated 20.09.2023
