Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/ SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O(Rt)No.3942 /2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority in the format prescribed in Kerala (Scheduled Castes and Scheduled Tribes)Regulation of Issue of Community Certificates Rules, 2002 and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No: 2/2020/P&ARD dated 12-02-2020 and Service Candidates should produce Service Certificate from the department along with other documents mentioned at the time of OTR verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on **04-08-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ERIVB(1)4062/2023/EW dated 15/11/2023.
