Note :- (3) The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) **75 (Seventy five)** candidates who have secured top most marks in the OMR examination are included in the Main list of this Short list. The mark secured by the last candidate in the Main list is **57 (Fifty Seven)** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Economically Weaker Section and Differently Abled, necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for **One Time Verification. Date,time and Venue of OTR Verification will be published later.**

Note :- (6) The register number of those candidate who do not produce the required documents within the prescribed time limit and whose applications found other wise defective will be deleted from the Short List without further notice.

Note :- (7) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non-Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate in Form III or digitally signed by the Revenue Authority not below the rank of Tahsildar and Candidates belonging to Economically Weaker Section(EWS) as per GO (MS)No.2/2020/P&ARDdated.12.02.2020 are required to produce certificate issued by the competent Revenue Authorities at the time of OTR verification.

Note :- (8) Copy of answer scripts of the OMR Test held on 24-07-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to **Notification No :ERII (3)4707/2023/EW dated 18.11.2023.**
