The marks secured by the last candidate in the Main List is **59.67 marks (Fifty Nine (Point) Six Seven)**. for the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary Supplementary List is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.”

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification and interview will be published shortly.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate (in form III/Digitally Signed Certificate) issued by the Competent Revenue Authority not below the rank of a Tahsildar as specified in Kerala Gazette and candidates belonging to other reservation communities are required to produce a Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 issued by the concerned Revenue Authority at the time of Verification. Candidates belong to EWS category should produce EWS certificate issued by concerned Revenue authority.

Note :- (7) Copy of answer scripts of the OMR Test held on **12.06.2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. The register number of candidate whose name and date not shown on photograph has been invalidated as per Letter No : ER11(2)4009/2023/EW Dated 01.11.2023
