The marks secured by the last candidate in the Main List is **52.67 (fifty two (point) six seven)** For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present in person for Physical Measurement and Physical Efficiency Test. Date, time and Venue of Physical Measurement and Physical Efficiency Test will be intimated through Profile Message and SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to SC/ST Community included in the Short List are required to produce Community Certificate issued by the Revenue authority and candidates belonging to Other Backward Classes included in the Probability List are required to produce Non-Creamy Layer Certificate as per GO(P)No.81/09/SC/ST DD dated 26/09/2009 issued by the Revenue authority and candidates belonging to EWS category are required to produce EWS certificate issued by the Revenue Authority at the time of OT Verification.

Note :- (7) The register number of those candidates who do not produce the required documents within prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on **05-09-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No : ER XVI(1)4674/22/EW Dated 30/12/2022
