Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (3) 51(Fifty One) candidates who have secured top most marks in the OMR examination are included in the main list of this Short List. The marks secured by the last candidates in the main list is **60.67 (sixty (point) six seven)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes , Scheduled Tribes,Other Backward Classes,Differently Abled (and other reserved categories if any) necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published in due course.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List , eligible for reservation are required to produce Non Creamy Layer Certificate /Community Certificate issued by the Revenue authority.Differently abled candidate should produce Medical Certificate at the time of OTR verification.Economically Weaker Sections are required to produce EWS certificate in the prescribed format for OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **21-07-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER(OSM)(3)4270/2023/EW dated 05-03-2024
