Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated through profile message and SMS.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Probability List ,eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009. SC/ST candidates included in the Probability List are required to produce Community Certificate (Form III / Digitally Signed) issued by the competent Revenue Authority and those belonging to Economically Weaker Section Category are required to produce EWS certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **13-09-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No : ERVII(1)5040/2023/EW dated 23/02/2024.
