Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification will be published shortly.

Note :- (5) Candidates included in the Short List ,eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 I Community Certificate issued by the Revenue authority / EWS Certificate as per G.O. (MS)No :02/2020/P&ARD dated 12/02/2020 and shall produce the same along with the other documents at the time of verification of original documents.

Note :- (6) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
