S. R. O. No. 1053/2010.— In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), the Government of Kerala hereby make the following rules further to amend the Special Rules for the Kerala Insurance Medical Subordinate Services, 1993 issued under notification G. O. (P) No. 24/93/P&ARD dated 29th March, 1993 and published as S. R. O. No. 1143/1993 in Part I Section IV of the Kerala Gazette No. 28 dated 13th July, 1993, na nely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Special Rules for the Kerala Insurance Medical Subordinate Services (Amendment) Rules, 2010.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Special Rules for the Kerala Insurance Medical Subordinate Services, 1993,—

(1) in rule 2,—

- (i) under Branch-II Homoeopathy, entries against Category I shall be omitted;
- (ii) under Branch-III Ayurveda (Indian Systems of Medicine), entries against Category I shall be omitted.

(2) in rule 3,—

- (i) under Branch-II Homoeopathy, entries against Category I shall be omitted;
- (ii) under Branch-III Ayurveda (Indian Systems of Medicine), entries against Category I shall be omitted.

(3) in rule 6, in the table,—

- (i) Under the heading Branch-II Homoeopathy, entries against serial number 1 shall be omitted;
- (ii) under the heading Branch-III Ayurveda (Indian Systems of Medicine), entries against serial number 1 shall be omitted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The posts of Medical Officers in Homoeopathy Department and Department of Indian System of Medicine have been included in their Special Rules for the State Services. But in Insurance Medical Services Department, the posts of Assistant Insurance Medical Officer (Homoeo) and Assistant Insurance Medical Officer (Ayurveda) still remain in the Special Rules for the Subordinate Services. It has been decided to include the above posts in the Special Rules for the Kerala Insurance Medical Services. Hence these posts have to be omitted from the Special Rules for the Kerala Insurance Medical Subordinate Services, 1993.

This notification is intended to achieve the above purpose.
